Eligibility for the University Examination

Statement of Purpose

To provide the list of criteria that determine the eligibility for the University Examinations.

Policy

The students shall be eligible to take the University examinations only if they fulfil the following criteria.

I. Undergraduate Program (MBBS)

A student is considered to be eligible to take the University examinations only if:

- The student has a minimum of 75% of attendance in the theory classes and a minimum of 80% attendance in the practical sessions / clinical posting in each subject.
- If a subject is taught in more than one phase, student shall have a minimum of 75% of attendance in the theory classes and a minimum of 80% attendance in the practical sessions / clinical postings in each phase.
- If an examination comprises more than one subject (e.g. General Surgery and allied), the student shall have a minimum of 75% of attendance in the theory classes and a minimum of 80% attendance in the practical sessions /clinical posting in each subject.
- Student shall have a minimum 75% attendance in electives to be eligible for third professional - part II examinations.
- The student has obtained an aggregate minimum of 50 % marks in the internal assessment in theory and practical combined and has obtained not less than 40% in theory and practical separately.
- The student has the completed the logbook.
- The student has completed the required certifiable competencies in all the subjects in that phase.
- The student has obtained hall ticket for the University examination after administrative clearance.

II. Postgraduate Degree Program (MD or MS)

A student is considered to be eligible to take the University examinations only if:

- The students has a minimum of 80% of attendance in the stipulated period of three years.
- The student has obtained a minimum of 50 % marks separately for both theory and practical in the internal assessment.
- The student has completed the thesis / dissertation work and has obtained approval from the University.
- The student has the completed and certified logbook.
- The student has done one poster presentation and one oral presentation during the course of three years.

- The student has submitted for publication or published at least one scientific article.
- The student has completed all the speciality postings within and outside the institution.
- The student has obtained hall ticket for the University examination after administrative clearance.

Definitions

Administrative clearance: The student shall obtain the administrative clearance for receiving the hall ticket if he/she (i) owes no dues to the institution, (ii) has no criminal or disciplinary actions pending and (iii) has paid the examination fees to the University.

Applies to

All the undergraduate and postgraduate students who have taken admission from the year 2019 onwards.
