Subject: Kerala University of Health Sciences, Thrissur - Recognition of DCH qualification for 2 seats in respect of students being trained at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum.

Sir / Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 29.05.2018 considered the Compliance verification Report (18.04.2018) and Council Assessor's Report(s) (July, 2015, 03.06.2016, 16.01.2017 & 08.09.2017) on the standard of examination and other teaching facilities available for Recognition of DCH qualification for 2 seats at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala granted by Kerala University of Health Sciences. The Committee decided as under:

The Postgraduate Medical Education Committee considered the Compliance verification Report (18.04.2018) and Council Assessor's Report(s) (July, 2015, 03.06.2016, 16.01.2017 & 08.09.2017) and decided to recommend to the Central Government that DCH qualification for 2 seats granted by Kerala University of Health Sciences in respect of students being trained at Sri Gokulam Medical College Trust & Research Foundation, Trivandrum, Kerala be recognized and included in the 1st Schedule to the I.M.C Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 12.06.2018
