Memorandum of Understanding (MOU) Between Snehita Women's Health Foundation and Sree Gokulam Medical College

Introduction:

This Memorandum of Understanding (MOU) outlines the collaboration between Snehita Women's Health Foundation and Sree Gokulam Medical College and Research Foundation (hereinafter referred to as "Gokulam Medical College"). Both organizations aim to enhance community health through joint efforts.

This Memorandum of Understanding (MOU) is executed on the 1st of August 2021 between: Snehita Women's Health Foundation (hereinafter referred to as "Snehita") represented by its Director, Dr. Regi Jose, hereinafter referred to as the "FIRST PARTY." And Sree Gokulam Medical College and Research Foundation, Venjaramoodu, Thiruvananthapuram, represented by its Dean Dr. Chandramohan, hereinafter referred to as the "SECOND PARTY."

Purpose and Nature of Business:

The purpose of this MOU is to establish a collaborative relationship between the FIRST PARTY and the SECOND PARTY for research projects, student training, and faculty exchange. Specifically:

Areas of Collaboration:

1. Research Collaboration:

- Both parties will collaborate on research projects related to Public Health.
- Joint research endeavors will enhance knowledge, promote scientific advancements, and contribute to healthcare improvement.



2. **Student Training Opportunities:**
 - o Create short-term and long-term training opportunities for students interested in Public Health, Disease Prevention, and Lifestyle Modification.
 - Undergraduate Medical students
 - Interns
 - Doctors pursuing postgraduate studies
3. **Ethics Committee Services:**
 - o Snehita may utilize the services of the Ethics Committee of Sree Gokulam Medical College for reviewing their research projects.
 - o Gokulam Medical College shall provide timely and efficient ethical review processes to support Snehita's research initiatives.
4. **Support for Community Activities:**
 - o Provide manpower and logistic support for community health programs.
 - o Collaborate on health camps, screenings, and awareness sessions in local communities, focusing on women's health issues.
5. **Volunteer Engagement:**
 - o Staff and interns from Gokulam Medical College interested in volunteering can join Snehita programs during holidays.


Term and Termination:

This MOU shall be in effect from the date of execution and continue for a period of three years. Either party may terminate this agreement by providing written notice at least one month prior to the intended termination date.


