



Eligibility and Duration For Various Programs

I. Undergraduate Program:

Eligibility:

Candidates must have:

- Completed Plus Two exam of state board (Higher Secondary Certificate or Plus two examination) or XII standard in CBSE or ISC Board with Physics, Chemistry, Biology and English subjects and must have obtained a minimum of 50% marks in the qualifying board exam for the general quota and a minimum of 45 % of marks for the other quota.
- Qualified in the NEET examination of that year, as evidenced by producing the score sheet with rank.
- Registered with Commissioner of Entrance Examination of Kerala to obtain state rank & allotment letter.
- Attained 17 years of age before 31st December of the year of admission.
- Eligibility certificate from the Kerala University of Health Sciences if they are from outside the state or NRI.

Program Duration:

4 & 1/2 years plus one year of Compulsory Rotational Internship.

II. Post Graduate Programs under the regulatory body Medical Council of India or National Medical Council (MCI or NMC):

Eligibility:

Candidates must have:

- Completed MBBS from any of the colleges recognised by Medical Council of India or from a foreign University.
- Completed the 1 year of Compulsory Rotatory Residential Internship.
- Obtained Permanent Registration Number from any state Medical Council (having cleared the licentiate exam for those graduating from foreign Universities).
- Qualified in the Postgraduate NEET examination of that year, as evidenced by producing score sheet.
- Registered with Commissioner of Entrance Examination of Kerala to obtain state rank & allotment letter.

- Eligibility certificate from the Kerala University of Health Sciences, if they graduated from other Universities and Equivalency Certificate from the Kerala University of Health Sciences if applicable.

Program Duration:

Three years.

III. Post Graduate Programs under the regulatory body National Board of Examination:

Eligibility:

Candidate must have:

- Completed MBBS from any of the colleges recognised by Medical Council of India or from a foreign University.
- Completed the 1 year of Compulsory Rotatory Residential Internship.
- Obtained Permanent Registration Number from any state Medical Council.
- Qualified in the DNB-CET or CET-NBE or NEET.

Program Duration:

Three Years

IV. Post Doctoral Programs under the regulatory body National Board of Examination:

Eligibility:

Candidates must have:

- Completed MD/MS from any of the colleges recognised by Medical Council of India or from a foreign University (recognised by MCI / Government of India) or Postgraduate DNB degree from any of the recognised institutions.
- Obtained Permanent Registration Number from any state Medical Council.
- Qualified in the DNB-CET-SS.

Program Duration:

Three Years
