College Council Committee

A. Composition of the Committee

The College council shall consist of the Vice Chairman, Dean Emeritus, Principal, Medical Superintendent, Deputy Medical Superintendent, Heads of the Department of all subjects, Wardens of both Men's and Ladies' hostels and Chairman of the Student Union. The Principal shall be the Chairperson and the Convener.

B. Statement of Purpose

The purpose of the College Council Committee is to facilitate and coordinate the academic activities of the undergraduate and postgraduate students of the college

C. Objectives/ Functions

The objective of the CC is to improve the quality of the academic milieu of the institution, in order to provide excellence in medical education.

D. Duties/Functions

• It shall be the duty of the Convener to give notice of the meeting of the Council, to keep a record of the proceedings of such meetings and submit them to the NMC / KUHS assessors during their assessment.

- Not less than three days' notice of a meeting shall ordinarily be given to the members. The notice is accompanied by the agenda.
- The Principal shall take the chair at all meetings of the Council.
- The Principal may overrule the decision of the College Council, but in such a
 case, he /she shall make a report to the Director setting forth the reason for
 doing so.
- The chairman shall be the sole judge of any point of order. He/she may call
 any member to order and shall have the power to take any action as may be
 necessary to enforce his /her decision.
- The general administration of the college shall vest in the Principal as per the
 regulations of the Director of Medical Education/KUHS/NMC. Some of the
 general administrative work of the college may be distributed by the
 Principal among the members of the Council to be done under the general
 supervision of the Principal e.g. Medical education, Curriculum committee,
 Anti-ragging measures, etc.

E. Frequency meetings

Meeting of the Council shall be convened ordinarily quarterly; but also may be convened at such time as the Principal may consider necessary
