

To protect a student's status and rights by providing support and opportunities as the leading organization

C. Objectives

- Bringing students together on the basis of their interests
- Expand skills among students and explore different elements of college life
- An organization to represent each student

D. Powers and duties

- Advocate for the rights and interests on general, academic and cultural areas
- Organizing events approved by the principal and college administration
- Representing the college in intercollege, state and national level
- Promote opportunities among the students

E. Procedure to register complaints:

- I. Contact details and e-mail address of all union members from each batch are made available
- II. Students can text or call or can directly meet the union members to discuss about their concerns

- III. Their issues will be considered seriously and would be dealt with considering privacy and safety of the student. Further proceedings will be done accordingly
- IV. Regular batch visits are done for addressing any problems in each batch
- V. Open discussion forums are also conducted and regular meetings are conducted for union members of each batch

F. Procedure to set up an appointment:

- I. Students can contact the union members to set up an appointment
- II. Union meetings will be conducted twice a week and appointments are usually given on the day of the scheduled union meeting
- III. If the matter is of utmost concern or requires privacy, it will be addressed by conducting a meeting with the available union members immediately without any delay
