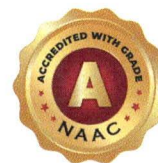

Purpose:

1. To monitor prescriptions and ensure compliance with the statutory, regulatory, and ethical standards.
2. To ensure the NMC mandate as in the order cited , 'every physician should prescribe drugs with generic names legibly and preferably in capital letters, and he/she shall ensure rational prescription and use of drugs.'

Terms of Reference


1. The Subcommittee shall:

- a. Develop a structured plan for systematic appraisal of prescriptions to assess compliance with applicable Regulations and guidelines.
- b. Review and analyze prescription patterns, identify deviations, and recommend corrective measures for improving adherence.
- c. Ensure that the findings of each appraisal are recorded in the minutes of the DTC meetings.
- d. Make such records available to the National Medical Commission whenever called for.
- e. Ensure timely implementation of all recommended measures to enhance compliance of the above terms as directed by NMC.
- f. Mandate inclusion of "Importance of Legible and Clear Handwriting in Medical Prescriptions" in medical training of all batches of MBBS and Postgraduate students of SGMC & RF.

2. Validity and other requirements:

- Validity of the committee is for a period of five years
- The committee shall meet quarterly and as needed.
- Member Secretary shall chair the meeting in absence of Chairperson; in addition to whom, the complete quorum shall be constituted by 3 members; having at least one Pharmacologist being mandatorily present.
